


#### Community support makes our work possible.

#### Message from the PRESIDENT/CEO

Ten years might not seem like a long time to some, but it is the milestone I have eclipsed this past year here at Auburn Valley Humane Society. It was yesterday when dozens of dedicated volunteers, three employees, and I performed all the daily duties at the animal shelter. As I look back at all the challenges and triumphs of the decade, I am reminded of the real reasons Auburn Valley Humane Society continues to change lives four paws at a time and be very successful at what we do.

2022 was again a year of growth and progress for the Auburn Valley Humane Society. This last year was a time of commitment and determination of our staff and dedicated volunteers to ensure our organization's continued success. We have grown stronger as an organization, strengthening our philosophies, beliefs, and practices and reaffirming our mission and dedication to the citizens and animals in the communities we serve. We are very excited to look forward to our future in animal welfare.

As 2022 ended, the dream of having a first-rate local animal sheltering facility ten years ago had become a reality. This past year, we revisited our mission and vision statements and reaffirmed our core values. As an organization, we review our policies, procedures, and always look to increase the quality of care for the homeless and abandoned animals in the shelter and the programs we provide to the community.

During this year of continued growth, I am proud of our organization's accomplishments. We are ever evolving and always seeking ways to pivot our efforts and continue ways to fulfil our vision and mission. Our dedicated staff and volunteers continued the hard work of fostering, caring, adopting homeless pets, and the humane education of children and adults throughout our community. Partnerships with local businesses continued to flourish. The strength of relationships AVHS had built with the City of Auburn, the local veterinary community, and King and Pierce Counties' citizens enabled us to grow stronger over the past year. Our donors' and supporters' generosity and concern for our efforts were critical in achieving our vision and mission. Our challenges we face in a post-pandemic world did not impact our fundraising efforts that so vitally assist us financially to support the animals in our care. Auburn Valley Humane Society Thrift Store & More also continued to thrive. Again, due to the thrift store's 2022 success, we continue to grow our Humane Services programs and fund these vital and much-needed services.

Our primary goal is always to find lasting, loving homes for the companion animals that come to us. In 2022, 597 dogs, 1091 cats, and 91 other animals were owner relinquished, transferred from other shelters, or found as lost animals and taken into our shelter. We gave them loving care, certified their health, administered all necessary vaccinations, microchipped them, evaluated their temperaments, and then spayed or neutered them. Many homeless or abandoned animals received necessary dental or extraordinary medical care. Once accepted into our shelter, there is no time limit on the animal's stay with us.

In 2022, we placed 1,213 pets into adoptive homes, and we reunited 215 lost pets with their owners. We also transferred 100 homeless pets to local rescue organizations. Because euthanasia is never our first choice, we are proud to report that our 2022 live release rate was 98%. AVHS reunited 39.66% of lost dogs and 6.43% of lost cats with their owners. All adopted animals left our shelter spayed or neutered, vaccinated, and microchipped. Auburn Valley Humane Society spayed or neutered 890 shelter animals and 181 public animals owned by income-gualified King

and Pierce County residents through our SPOT program. In 2022, a Veterinary Wellness program was launched at Northwest Spay & Neuter Center and performed 2,480 wellness exams for the pets of income-qualified residents in our community. NWSNC also broke all previous organizational records in 2022 by performing spay or neuter surgeries on 3,285 non-profit partner animals and 11,399 public dogs and cats for 14,684 animals.



We are not only an animal shelter, adoption agency, and spay and neuter clinic; AVHS is also an educational organization. Community outreach is a vital part of our organization. Over 408 active volunteers spent 18,936 hours at our offsite adoption sites, cleaning kennels and cages, caring for 477 dogs and cats in foster care, doing laundry and dishes, constructing enrichment toys for the animals in our care, walking dogs, helping with customer service, at the thrift store and fundraising. Thanks to our dedicated volunteers and staff, we can inform the world of our progress through our websites, and AVHS social media pages.

Over the past year, our Board of Directors has grown and given valued direction and support. We have diversified and maintained our revenue stream and successfully navigated our expenditures. We also grew our important animal-related/human service programs. The Public Veterinary Assistance and the Pets in Crisis funds assisted the owners of 51 animals with emergency medical care and boarding needs. The Pets for Life program provided support for 405 animals. 98 pets of 36 owners in need were assisted monthly through the AVHS Shelter Pet Pantry program. Northwest Spay & Neuter Center pet pantry provided 3,063 pounds of food to pets in need. Due to the success of the Shelter Buddies Reading Program, 76 children spent their time reading to our cats in feline adoption. The Girl Scout Badge program saw 78 Girl Scouts received their AVHS patch in 2022. We continued a memorandum of understanding with King County and DAWN to house the pets of domestic violence victims in our community. We partnered with Seattle Humane Society for the Pets of Seniors Food Bank, which continues to arow

Acknowledgment for these many successes again goes to our dedicated staff and volunteers, the support of the City of Auburn and neighboring animal sheltering agencies, and the generous devotion of the King and Pierce Counties' citizens ... and especially, the faithful financial donors and supporters of Auburn Valley Humane Society.

Once again, as in the past ten years, we have ended 2022 as an essential and vital part of our community. We are thankful and proud of our 2022 accomplishments; look forward to significant growth again in 2023. We could not have done it without your help, and we are honored to be here among you still, continuing our mission and changing lives... four paws at a time!







INTAKES

## OUTCOMES

Auburn Valley Humane Society strives to find a loving family for every adoptable animal. The outcomes include animals that were adopted, transferred to rescue groups, reunited with their owners, died in shelter, DOA (dead on arrival), euthanasia medical/behavior and owne requested euthanasia.

AVHS does not euthanize animals for time limits, space or age of the animal. AVHS utilizes every resource possible to find forever homes for the animals in our care.






Dereka, a 5-year-old medium-breed dog, came into the shelter as a stray with some health concerns. She was experiencing pain walking. She would lie in her bed. Typically dogs go out for walks three times a day, but she did not want to leave her bed for walks because her paws hurt so much. A foster home would provide her with more comfort than being at the shelter.

Meanwhile, our veterinary team started diagnosing what was causing her pain. After testing, the team discovered she had a rare autoimmune disease. While it was possible to treat and alleviate her pain, the team knew the need for lifelong management of her autoimmune condition might make it difficult for her to find a home.

Much to everyone's delight (especially Dereka), she found a wonderful home almost immediately after she was made available for adoption. Her incredible new family was more than willing to provide her with the lifelong care and support she needed. She also has a new canine companion who she absolutely adores!





## MEDICAL STAFF AT WORK

In 2022, Auburn Valley Humane Society medical and animal care staff provide quality, loving care to every animal who comes into our shelter. The animals in our care receive physical exams, vaccinations, spay/neuter services, microchips and in some cases, extensive medical and dental care prior to adoption to a loving family.

## JOJO



It all started when JoJo, a 6 year-old tabby cat, was brought to vet services to see if we could help his itchy skin rather than euthanize him. He had two years of previous treatment that hadn't helped. The awesome medical staff did a biopsy which confirmed he had a severe immune mediated disease that made him itchy. He went to a wonderful foster home to heal and being on the right meds, his skin cleared up. He was adopted after 3 months of treatment and care.

## FINN

It all started when Finn was brought to another Washington shelter with a fractured leg and jaw. The shelter was unable to provide the medical care needed to help Finn. He was transferred to Auburn Valley Humane Society to our program. He was evaluated by the veterinary medical team. His leg was amputated due to multiple fractures in his front limb that could not be fixed. He had dental surgery to help his jaw heal. He went to foster care for a few weeks to recover. He was recently adopted. He's a bouncy, loving, and very social pup.



## ANIMAL WELFARE STAFF AT WORK


One of the ways we measure our success is by how long a cat or dog is in the shelter before they are adopted. The smaller the number, the sooner they go to a new home and the more animals can come to us for lifesaving care. Moving animals through the shelter faster reduces stress and illness.

7.2 days for dogs for 2022 8.6 days for cats in 2022



## KING OF KONGS



At Auburn Valley Humane Society, we recognize volunteers' importance and ingenuity. Volunteer, Rick Gaston, created a new way to participate in our Project Paws Enrichment Program. He bought a sausage stuffer, which he uses to stuff Kongs for our shelter dogs. You can only imagine using a spoon to put wet food, kibble, and treats through the hole at the top!

Enrichments are a combination of toy and treat given to shelter animals to help relieve stress and boredom.

Kongs are a big hit with dogs each day. The kongs are frozen after being stuffed with canned dog food, peanut butter, squeezy cheese, and various dried dog treats. Rick's stuffing method is guicker and much less messy than doing it by hand. His wife has nicknamed him "King of Kongs."

## PETS IN CRISIS

At Auburn Valley Humane Society, we recognize the importance of the human-pet bond. We are willing to work with the family to assist with various pet needs when a family is experiencing housing insecurity, job loss, or medical issues. Our Pets in Crisis Program assists with temporary housing and care for owned pets when the pet owner has a medical crisis or loss of housing.

Mark's cats, Nico and Chiave, entered our Pets in Crisis program in mid-May as Mark was in a coma in the hospital, and Mark's mother could not care for the cats. Luckily, AVHS was able to get them into a foster home very quickly. At the end of 30 days AVHS staff feared his cats would end up being surrendered to the shelter.

Miraculously, Mark woke up from his coma! He had a speedy recovery and could not wait to be with his cats. A happy ending with Mark and his cats reunited!







## PET LICENSING

AVHS is contracted to be the service provider for pet licensing for the City of Auburn.

## Why license my pet?

- Licensing your Pet is the law.
- All dogs and cats over 8 weeks of age that reside in the City of Auburn require a pet license.
- Pets without a license are subject to fines and penalties.
- Having a pet license quickly reunites a lost pet with their owner.
- Funds received through pet licensing benefit the animals in the City's care at AVHS.



Artie, a four year old male Pit Bull Terrier Mix, was a sweet, well-mannered guy. He loves going for walks and cuddling with his people. He is very energetic and playful. AVHS staff didn't give up on him and finally was able to match him with the right family that could spend time with him, train him and keep him active.

Auburn Valley Humane Society Thrift Store & More is more than a thrift store with housewares, tools, books, videos, clothing and pet items, pet kennels and so much more. It has dealer consignment booths featuring antiques, jewelry, specialty items and collectible treasures. 100% of the proceeds benefit the lost and abandoned animals at the AVHS animal shelter and funds humane programs.
